

## **ORDINANCE 2021-25**

Date: December 1<sup>st</sup>, 2021

Subject: Yellow-level measures in the Nunavik communities

**WHEREAS** the risk of transmission of COVID-19 remains present in all the Nunavik communities, even those where no cases have been reported recently;

WHEREAS preventive measures are necessary to protect the health of the population;

**WHEREAS** the risk of COVID-19 is lower in communities with a high vaccination coverage, as long as there is no evidence of community transmission;

**WHEREAS** continuous surveillance of COVID-19 through screening tests is carried out regularly every week, especially with symptomatic people;

The following measures are applicable for the **Yellow alert level**:

Restaurant	10 people max. at the same table or occupants of 3 residences	Yes, except when seated for meals	Yes	Distancing of 2 meters between tables
Indoor sports activity	25 players maximum/ 25 spectators maximum	At all times for spectators	Yes	Distancing of 2 meters between spectators not living in same residence
Gym	Number enabling distancing of 2 meters between machines	Yes, except when at machine	Yes	Distancing of 2 meters between participants
Church	250 persons maximum	At all times	No	Distancing of 2 meters between persons not living in same residence
Outdoor get- together	250 persons maximum	No	No	Distancing of 2 meters between persons not living in same residence
Workplace	<ul> <li>Open to workers</li> <li>Telework when possible</li> <li>No visitors except for the delivery of essential services</li> </ul>	When at less than 2 meters from clientele or colleague	No	2 meters or physical barrier when possible

Any person with symptoms compatible with COVID-19, such as fever, unusual cough, breathing difficulties, loss of the sense of taste or smell, nasal congestion, sore throat, unusual fatigue and headache, or any person who believes he or she has been in contact with a person with COVID-19 must refrain from frequenting any public place or visiting other homes. An appointment must be obtained for COVID-19 testing.

Restrictions on travel, as identified in Ordinance 2021-16-1 dated December 1<sup>st</sup>, 2021, shall remain in effect until further notice.
